- Rate quoted be valid for 60 days from the date of opening of the tender.
- 2. Taxes, duties if any should be mentioned clearly.
- 3. The rates must be stated for each item separately both in words & figures.
- 4. The contract will be for "Comprehensive Maintenance Services" i.e. if any part is required to be replaced, the same will have to be replaced under the contract and no extra charges will be paid by the college for any spare part including wires.
- Maintenance services will be provided on frequent basis without call form the college which will include:
  - a) Checking and Servicing of each unit every month.
  - b) Attending to the unit when called upon by the college without any extra charge within four hours of the complaint call.
  - c) Changing and repairing the unit or parts thereof as also overhauling the unit, free of charge at the service station of the Service Provider, if required.
  - d) Supplying free of charge all spares and materials, which are needed for the unit.
  - e) Efficient and experienced technicians will be sent for attending the CCTV complaint.

No data should be taken without the permission of the college.

6. Contract can be terminated by the college immediately if the conduct of the Service Provider or any of higher employee(s) is found to be detrimental to the safety of the property, student and employees of the college or any such other action by the Service Provider or any of his/her employee(s) which the College Authorities may deem fit, to be given in writing, for termination of the contract.

7. Strict confidentiality is to be maintained for the college data,

 Safety of the employee(s), if any, of the Service Provider shall be the sole responsibility of the Service Provider.
